1. 3. The collected personal data will be processed for the purposes of:
 - a) consideration of the declaration in connection with the need to verify the fulfillment of the membership acquisition criteria - (the legal basis for data processing in this case is the Administrator's legitimate interest - Article 6(1)(f) of the GDPR)
 - b) Acquiring membership in the Association, exercising the rights and obligations of a member of the Association, settlement of membership fees paid (fulfillment by the administrator of legal obligations under the law - Article 6(1)(c) of the GDPR).

 - d) fulfillment of obligations arising from the statute - (Article 6(1)(b) of the GDPR.)
